GUEST SPEAKER óUpcoming Referendum ó KELLY GRANT

Kelly Grant spoke about the upcoming referendum for the middle/elementary school. The last 2 times that it was up for vote the information was very clinical rather than informative. She is working to get the information to parents, law enforcement, businesses, & chamber as they were not informed very well in the past. Care of the school and the children¢ learning environment impact movement of people to the city. K-8 will mimic STEM center of high school. Locker rooms and the difference there is now for the genders will be addressed. There is congestion. Traffic Pattern is being researched. The advocacy cannot be paid for by the schools. Kelly is asking for a donation of \$300 toward a \$1200 budget for signage. Money will go through the PTO, not through the school. She would like to have signs out by October 1st. November 5th is the vote. People will have to find their voting poll as Brillion School district has various voting stations such as City, Town of Brillion, Maple Grove & Rockland. Discussion followed.
